

No.A/4/NSP/OBC&SC-2021: The second state of the second scholarship Schemes viz., OBC (Pre-Matric & Post-Matric), SC (Pre-Matric & Post-Matric) and EBC based Scholarship Schemes for students belonging to the notified OBC, SC and EBC Community for the year 2021-22 have been opened on National Scholarship Portal (NSP) as per the timeline and conditions laid hereunder:

Only online applications under the Schemes will be accepted and no request for Offline applications will be entertained. Website for filling up of Online Scholarship application is <a href="www.scholarships.gov.in">www.scholarships.gov.in</a>. A link to this site is also available in the website of the Ministry (<a href="https://socialjustice.nic.in/">https://socialjustice.nic.in/</a>) and also in the Official Website of this Directorate (<a href="www.manipurobcsc.gov.in">www.manipurobcsc.gov.in</a>). Alternatively, application may also be submitted through NSP App by downloading the same from Google Play Store.

- 2. The following conditions/points are to be noted while registering for OBC, SC & EBC Scholarships, 2020-21 at NSP:
  - Scholarships are awarded under these Schemes to the notified OBC, SC and EBC Communities pursuing studies in India in a Government or recognized private university/institute/college/school.
  - Detailed Guidelines of the 5 (five) Scholarship Schemes and Standard Operation are available on NSP Homepage at <a href="https://www.scholarships.gov.in"><u>www.scholarships.gov.in</u></a>.
  - iii. Fresh applicant(s) have to register at NSP to get Login Credentials and fill-up the entry form by entering complete details to get the Registration ID.
  - iv. All Verifiying Authorities (INO/SNO) can mark an application fake if he/she is satisfied that the applicant is not a bonafide student. In other circumstances, in case of non-fulfillment of eligibility criteria or inconsistency of records, the verifying authority may either reject the application or mark it defective and give the applicant another opportunity to correct their records.
  - v. It needs to be noted by all the INOs and SNOs that in case if any application is marked fake at L2 Level by the SNO then the entire bunch of applications from that School/Institute will go back to the respective INO login of that School/Institute for re-verification. Hence the SNOs are advised to exercise caution while using the option of marking an application fake.



- Aadhaar number/Aadhaar Enrolment, ID slip/ Bank passbook with photograph are required as vi. identification documents. Aadhaar demographic authentication based on applicant's details i.e. name, gender and year of birth as given in Aadhaar has been introduced on NSP Portal.
- Print out of the online application along with seft-attested photocopies of supporting documents is to vii. be submitted to the concerned Institute. If the documents are not uploaded on NSP while registering online application, then the set of documents shall be submitted to the Directorate for Welfare of OBCs & SCs, Manipur for OBC (Pre-Matric & Post-Matric), SC (Pre-Matric & Post-Matric) and EBC Schemes.
- Academic attendance should be minimum 75%. The INOs shall ensure that students below 75% viii. attendance are not verified and recommend for scholarship. ix.
  - Scholarship Scheme Certificate: OBC, SC certificate of the applicant issued by the competent authorities/executive magistrates.
  - Income Certificate: Income certificate of father/mother/guardian/husband ending 31st March of the X. current year in original issued by the competent authorities/executive magistrates. The present income ceiling for entitlement of the scheme as prescribed by the sponsoring Ministry is
    - ✓ 1 lakh per annum for Economically Backward Classes (Post-Matric).
    - ✓ 1.5 lakh per annum for Other Backward Classes (Post-Matric) and 2.5 lakh per annum for Other Backward Classes (Pre-Matric)
    - √ 2.5 lakh per annum for Scheduled Caste (Post-Matric) and 2.5 lakh per annum for Scheduled Caste (Pre-Matric)
- EBC Self Declaration Certificate: Counter Sign by the Head of Institute. xi.
- xii. Institute Verification Form.
- Date of Birth Certificate: Upload class X certificate for Post-Matric and for Pre-Matric, Date of Birth xiii. certificate issued by the competent authorities/executive magistrates
- xiv. Bank Passbook.
- XV. Marksheet/Admit Card.
- Aadhar Card. xvi.
- 3. For EBC Scholarship scheme, students studying in Government School(s) / College(s) / Institute(s) only are eligible.
- Aadhaar based demographic authentication of Institute/State Nodal Officers is required. All 4. Stakeholders are requested to update the Aadhaar No. of both the INO (along with the mobile number link with the Aadhaar) and the Head of the Institute on the NSP. If the INO is unable to do so, then kindly submit the Annexed Form to our Directorate at the earliest so that their students can apply and cause verifications of their applications on the portal without any delay.
