- 2. Only online applications under the Schemes will be accepted and no request for offline applications will be entertained. Website for filling up of Online Scholarship Application is www.scholarships.gov.in. A link to this site is also available in the website of this Directorate (www.manipurobcsc.gov.in). Alternatively, application may also be submitted through NSP App by downloading the same from Google Play Store.
- 4. The following conditions/points are to be noted while registering for OBC, SC & EBC Scholarships, 2022-23 at NSP:
 - i. As per revised scheme guidelines, Pre-Matric Scholarship for OBC & EBC will be awarded to those students studying in class IX and X on a full-time basis in Government School only. Detailed Guidelines of Scholarship Schemes and Standard Operation are available on NSP Homepage at www.scholarships.gov.in.
 - ii. Fresh applicant(s) have to register at NSP to get Login Credentials and fill-up the entry form by entering complete details to get the Registration ID. All Renewal applicant(s), who have received SMS for renewal option and continuing the same course, may register using their existing Scholarship Application ID.
 - iii. Aadhaar Number/Aadhar Enrolment ID Slip/Bank Passbook with photograph are required as Identification documents. Aadhaar demographic authentication based on applicants details i.e. name, gender, and year of birth as given in Aadhaar has been introduced on NSP Portal.
 - iv. All verifying authorities (INO/SNO) can mark an application fake if he/she is satisfied that the applicant is not a Bonafide student. In other circumstances, in case of non-fulfillment of eligibility criteria or inconsistency of records, the verifying authority may either reject the application or mark it defective and give the applicant another opportunity to correct their records.
 - v. Aadhar based demographic authentication of Institute/State Nodal Officer is required. All stakeholders are requested to update the Aadhaar number of both the INO (along with mobile number linked with the Aadhaar) and the Head of the Institute on NSP. If the INO is unable to do so, then kindly submit the **Annexed Form** to our Directorate at the earliest so that their students can apply and cause verifications of their applications on the Portal without any delay.

- vi. Academic attendance should be minimum 75%. The INOs shall ensure that students below 75% attendance are not verified.
- vii. For EBC Scholarship scheme, students studying in Government School(s) / College(s) / Institute(s) only are eligible.

viii. Documents to be uploaded:

- a) Student photograph.
- b) Caste Certificate: OBC, EBC & SC certificate of the applicant issued by the Competent Authorities/Executive Magistrates.
- c) Income Certificate: 2.5 lakh per annum for OBC (Pre-Matric & Post-Matric), SC (Pre-Matric & Post-Matric) and EBC (Pre-Matric & Post-Matric).
- d) Bonafide student of Institution Certificate (Certificate form available on NSP)
- e) Date of Birth Certificate: Upload class X certificate for Post-Matric and for Pre-Matric, Date of Birth certificate issued by the Competent Authorities/Executive Magistrates
- f) Bank Passbook.
- g) Self-Attested Certificate of previous Academic Marksheet / Admit Card.
- h) Admission Receipt
- i) Gap year Certificate: Students having a study break of less than 3 (three) years should upload an Affidavit/Break Certificate stating the reason of break in his/her academic studies from the competent authority. Students having a study break of more than 3 (three) year will not be eligible for this Scholarship under any circumstances.
