3. No offline forms will be issued and no forms shall be accepted physically.

4. **Last date for online form submission: 10-03-2026**

5. **Eligibility of Beneficiaries as per the PM-AJAY Scheme:**

- a) Age of beneficiary: above 18 years of age.
- b) Priority shall be given to families /persons having annual income not more than Rs.2.50 lakhs per annum.
- c) 30 percent of the beneficiaries shall be earmarked for women candidates in each trade.
- d) 50 percent of the beneficiaries shall be earmarked for Internally Displaced Persons from SC communities as per Government letter No. MISEC-2/1/2024-OBC& SC- OBC & SC, dated 30-08-2024.




6. The workflow of the Scheme is as follows:
